1. MORS Form 712B is required for all papers and presentations.
2. Title 18 United States Code 1001 makes it a criminal offense, punishable by a maximum of five (5) years imprisonment, a fine, or both, to knowingly and willfully make a false statement or representation to any department or agency of the United States, as to any matter within the jurisdiction of any department or agency of the United States. This includes any statement made herein which is knowingly incorrect, incomplete or misleading in any important particular.
3. Submission of this form does NOT guarantee an opportunity to present a paper at the Military Operations Research Society Symposium, Special Meeting or Workshop. Such invitation will be issued separately.
4. Fill in all the blanks. If Form 712B is not complete, it will be sent back for completion.
5. Form 712B shall be originated by the author who fills in and signs **Part I** and attaches an unclassified paragraph abstract.
6. The Releasing Official, i.e., the person who has the authority to say that it is permissible to disclose subject information at the symposium, fills in and signs **Parts II** and forwards it to the MORS Security Manager at the address ABOVE. **FAXED, EMAILED AND MAILED copies** (703-933-9066) **WILL** be accepted.

Distribution Statements per DoD Directive 5230.24

1. Distribution Statement A. This presentation/paper is unclassified, approved for public release, distribution unlimited, and is exempt from U.S. export licensing and other export approvals under the International Traffic in Arms Regulations (22 CFR 120 et seq.)

2. Distribution Statement B. Distribution authorized to US Government agencies only (fill in reason) (date of determination). Other requests for this document shall be referred to (insert controlling DoD office). **Reasons for assigning distribution statement B include:** 1. *Foreign Government Information:* To protect and limit distribution in accordance with the desires of the foreign government that furnished the technical information. Information of this type normally is classified at the CONFIDENTIAL level or higher in accordance with DoD 5200.1-R (reference [h]). 2. *Proprietary Information:* To protect information not owned by the US Government and protected by a contractor's "limited rights" statement, or received with the understanding that it not be routinely transmitted outside the US Government. 3. *Test and Evaluation:* To protect results of test and evaluation of commercial products or military hardware when such disclosure may cause unfair advantage or disadvantage to the manufacturer of the product. 4. *Contractor Performance Evaluation:* To protect information in management reviews, records, or contract performance evaluation, or other advisory documents evaluating programs of contractors. 5. *Administrative or Operational Use:* To protect technical or operational data or information from automatic dissemination under the International Exchange Program or by other means. This protection covers publications required solely for official use or strictly for administrative or operational purposes. This statement may be applied to manuals, pamphlets, technical orders, technical reports and other publications containing valuable technical or operational data. 6. *Software Documentation:* Releasable only in accordance with the provisions of DoD Instruction 7930.2 (reference [I]). 7. *Specific Authority:* To protect information not specifically included in the above reasons and discussions, but which requires protection in accordance with valid documented authority such as Executive Orders, classification guidelines, DoD or DoD Component regulatory documents. When filling in the reason, cite "Specific Authority (identification of valid documented authority)."

3. Distribution Statement C. Distribution authorized to US Government agencies and their contractors (fill in reason) (date of determination). Other requests for this document shall be referred to (insert controlling DoD office). **Reasons for assigning distribution statement C include:** 1. *Critical Technology:* To protect information and technical data that advance current technology or describe new technology in an area of significant or potentially significant military application or that relate to a specific military deficiency of a potential adversary. 2. *Administrative or Operational Use:* Same as distribution statement B. 3. *Specific Authority:* Same as distribution statement B.

4. Distribution Statement D. Distribution authorized to the Department of Defense and DoD contractors only (fill in reason) (date of determination). Other requests shall be referred to (insert controlling DoD office). **Reasons for assigning distribution statement D include:** 1. *Premature Dissemination:* To protect information on systems or hardware in the development or concept stage to prevent premature

dissemination. 2. *Software Documentation*: Same as distribution statement B. 3. *Critical Technology*: Same as distribution statement C. 4. *Specific Authority*: Same as distribution statement B.

5. **Distribution Statement E**. Distribution authorized to DoD Components only (fill in reason) (date of determination). Other requests shall be referred to (insert controlling DoD office). **Reasons for assigning distribution statement E include:** 1. *Export Limitations*: Document contains export-controlled technical data which has been designated by competent authority in accordance with DoD Directive 5230.25 (reference f) to be of such significance for military purposes that release for purposes other than direct support of DoD-approved activities may jeopardize an important technological or operational military advantage of the United States. 2. *Foreign Government Information*: Same as distribution statement B. 3. *Premature Dissemination*: Same as distribution statement D. 4. *Software Documentation*: Same as distribution statement B. 5. *Critical Technology*: Same as distribution statement C. 6. *Specific Authority*: Same as distribution statement B.

6. **Distribution Statement F**. Further dissemination only as directed by (insert controlling DoD office) (date of determination) or higher DoD authority.
